Week 8 – Unfinished Business

As the Legislature sprints into the final week of the 2014 regular session, there is a lot of very important unfinished business out there.

The House Judiciary Committee has just begun to mark up an 80-page working draft of a new version of SB 373, also known as "the water bill" or the Aboveground Storage Tank Act.

The committee had its first look at this new draft Thursday afternoon. They will work the bill again this afternoon, and the plan is to come back Sunday afternoon to further work the bill. Ostensibly, the goal is to pass a bill Sunday evening.

But everyone is not happy in Judiciary Committee land. Some delegates are upset that they have not had enough input into the bill. Others are upset that there is not enough time left to consider the bill. And Del. Meshea Poore (D-Kanawha) sent Gov. Earl Ray Tomblin asking him to call a special session to focus solely on the water bill. The letter

was signed by a bipartisan group of 26 other delegates, including Minority Leader Tim Armstead (R-Kanawha).

A special session?? Please say it is not so!

Frankly, folks, there are a lot of good things included in this Judiciary draft bill. Is it perfect? No. But the provisions already included would provide significant new regulation for protecting water supplies across the state.

Now is not the time to start over. Now is the time for the House to pass their version of SB 373, and send it back to the Senate for its consideration.

Let's get it done.

Seems like there is not much of a reprieve from winter's blast. So please keep your birdfeeders full for our fine-feathered friends.

#### **Weekly Statehouse Aquapocalypse Update**

On Monday, Governor Tomblin's office issued a press release titled, "Governor Tomblin Meets with EPA Administrator to Provide Update on Elk River Chemical Spill." But the Governor also hand delivered to Administrator McCarthy a letter providing recommendations for establishing carbon dioxide emission guidelines for existing power plants; one wonders which was the real reason for the meeting. Also on Monday, the West Virginia Rivers Coalition and Downstream Strategies released a new report on potential sources of contamination of the Elk River above Charleston's West Virginia American Water treatment plant intake. In the words of the press release, the report "provides a preliminary assessment of sites that, if improperly managed, could contaminate West Virginia American Water's Charleston drinking water intake . . . In response to a Freedom of Information Act request, the West Virginia Bureau for Public Health provided a list of 62 potential significant contaminant sources that could quickly impact the Charleston drinking water intake. The new report outlines the character of these sites," as well as whether and how they are regulated.

On Wednesday morning, Evan Hansen of Downstream Strategies gave a presentation on the new report to the House Judiciary Committee, where S.B. 373 now sits. Evan

also answered many questions asked by committee members. We are thrilled that the Judiciary Committee and other House members are wisely giving so much well-deserved credence to Evan's expertise!

Since Wednesday was the deadline for passage of bills by their house of origin, legislators have been spending a great deal of time in floor sessions while House Judiciary legal staff has worked to fine-tune S.B. 373. Finally on Thursday afternoon, the Committee's draft was released and the committee spent about an hour and a half discussing it. Here's a summary of the major changes:

- Recall that the House Health and Human Resources Committee (HHR) added a requirement that by July 1, 2016, public water utilities must submit source water protection plans. Judiciary's version requires more extensive information and analysis to be performed and submitted as part of these SWPPs, as well as extensive information regarding the operation of the plant.
- HHR added a requirement that public water systems install a second intake and/or capacity for 3-5 days' storage. This requirement was removed. Instead, water systems with a single intake must include in their SWPPs an analysis of the technical and economic feasibility of pursuing one or more other alternatives that would allow for continued and reliable water service should the public water supply become unavailable or unreliable due to contamination or another reason. Among these alternatives are construction of a second intake and construction of additional storage. If one or more alternatives appear feasible, the public water system is to perform a cost/benefit analysis of pursuing the option.
- Judiciary's version eliminates the exemptions found in previous versions, and confines "waivers" to the following: 1) water; 2) natural gas or propane tanks, which are regulated elsewhere; 3) septic tanks; 4) pipeline facilities and hazardous materials pipeline, both of which are regulated elsewhere; 5) equipment or machinery containing substances used for operational purposes; 6) mobile tanks, trucks or railcars that are located on a site for less than 60 consecutive days; 7) liquid traps or gathering lines associated with oil and gas production; and 8) surface impoundments, pits, ponds or lagoons. Waivers for other categories of ASTs may be granted by the DEP by legislative rule.
- Judiciary's version also redefines aboveground storage tank to include tanks "made to contain an accumulation of more than 1320 gallons of fluids that are liquids at standard temperature and pressure," and then goes on to discuss tank construction materials, etc. Presumably, this 1320-gallon figure comes from 40 CFR 112 on oil pollution prevention . . . but that regulation applies the 1320-gallon figure to the "aggregate aboveground storage capacity of the facility," and not to individual tanks.

- Also excluded are "process vessels," which are vessels or containers used to manufacture or mix chemicals.
- The definition of "secondary containment" was also revised to make it clear that the constraining structure is required to have an impermeable base, and be of sufficient capacity to contain the entire contents or the single tank or the largest tank, even with additional rain entering the containment structure. The structure must also prevent any leaking fluids from entering groundwater, or breeching the containment and flowing into surface waters.
- In order to facilitate the DEP's inventory of all aboveground storage tanks, owners of all tanks meeting the bill's definition would be required to submit a registration form to identify the tanks' characteristics and contents as of July 1, 2014.
- Any NPDES permit within a zone of critical concern for a public water system's intake must be an individual rather than a general permit.
- The abstract goes on to say that "Specific citizen suit language will be added to the draft, consistent with this right to enforce violation of the NPDES permit standards as a violation of the Federal Clean Water Act."

## It's Time to Let Your Legislators Know You DON'T Want Our Municipal Solid Waste Landfills Filled With Drill Cuttings!

The House of Delegates on Wednesday passed HB 4411 on a vote of 81 -15, with 4 members not voting. The bill as drafted still allows unlimited amounts of drilling mud and drill cuttings to be deposited in commercial landfills, with no exemptions for our small Class B landfills. A floor amendment offered by Delegate Dave Pethtel (D-Wetzel) and Delegate Mike Manypenny (D-Taylor) would have protected current tonnage caps for Class B landfills. The amendment was defeated by voice vote. The bill now goes to the Senate.

Ask them to insist that legislation regulating the disposal of drill cuttings creates **separate** hazardous waste landfills **specifically for drill cuttings**; that those landfills be **paid** for by the <u>drilling companies</u> **not** by tax payers; and that monitoring of the waste and the leachate for radioactivity and toxicity be required.

SB 461, the WV Future Fund Bill, passed the Senate on February 21<sup>st</sup> and is now sitting and waiting for action along with a slew of other bills in the House Judiciary committee.
